Treatment Overview and Requirements

Overview

Mr Sharpe - Consultant Orthopaedic Foot, Ankle and Trauma Surgeon has recommended the following:

- Targeted injection of anaesthetic and steroids under image guidance.

- Ankle Arthroscopy and debridement (if needed following targeted injection therapy).
- Arthroscopic ankle fusion (may be needed if pain and discomfort continue after Arthroscopy and debridement).
- Orthotics assessment plus footwear modification.

Other Considerations

Within the first report dated 20/06/2023 Mr Sharpe mentions the need for continuing physiotherapy, however nothing further was mentioned regarding this in subsequent reports. However, due to the recommended therapy noted above, physiotherapy will be as essential part of the rehabilitation plan, to ensure the best outcome of the recommended therapies. Therefore, it is further recommended that a Physiotherapy referral takes place for initial assessment plus 20 therapy sessions.

Due to the complexity of this case, there will be a need for ongoing clinical management, to ensure the treatment plan is co-ordinated and services are integrated at the appropriate time to optimize rehabilitation outcomes. This will also include monitoring and evaluation throughout the rehabilitation period to ensure optimum recovery.
